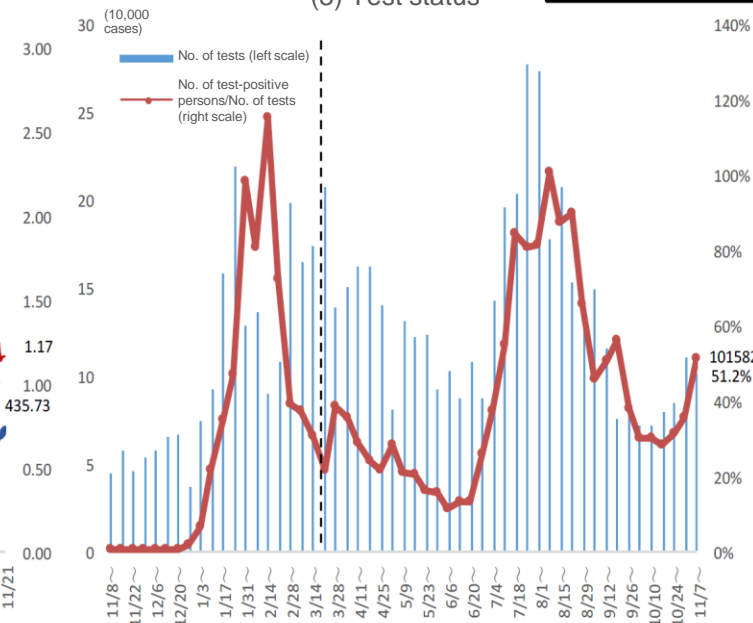
(1) No. of new cases of infection reported



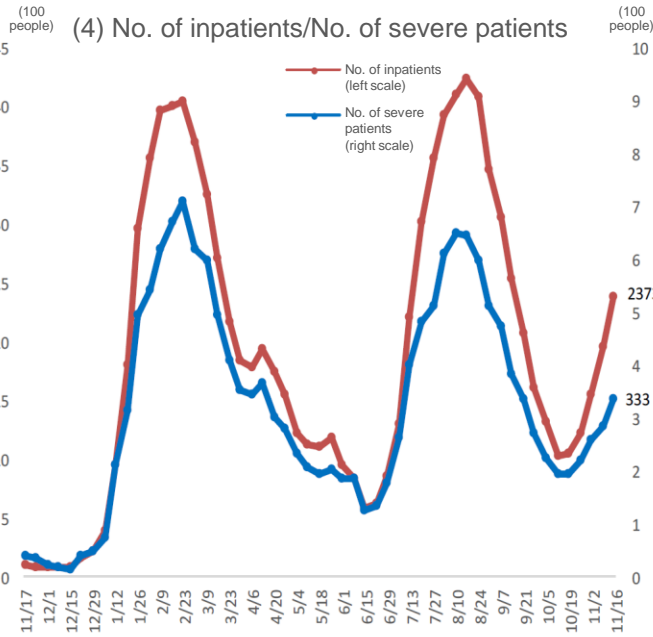
(2) No. of new positive cases (per 100,000 of the population) / ratio to the previous week



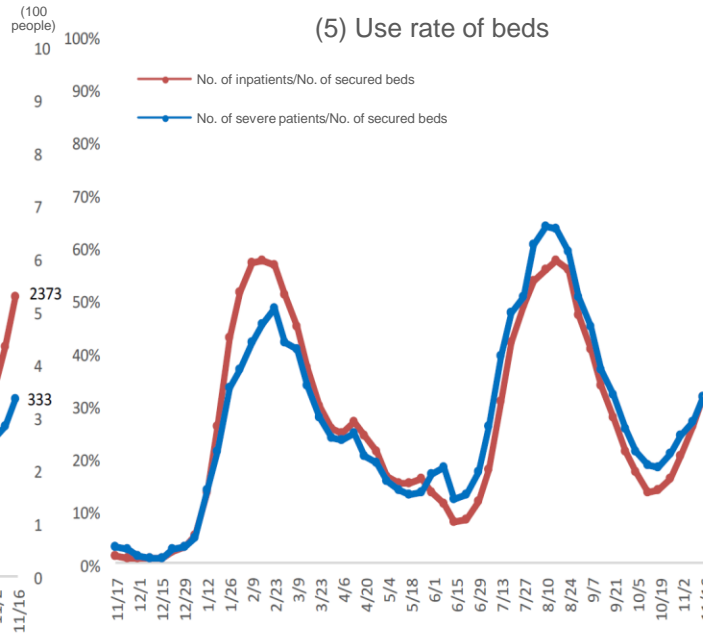
