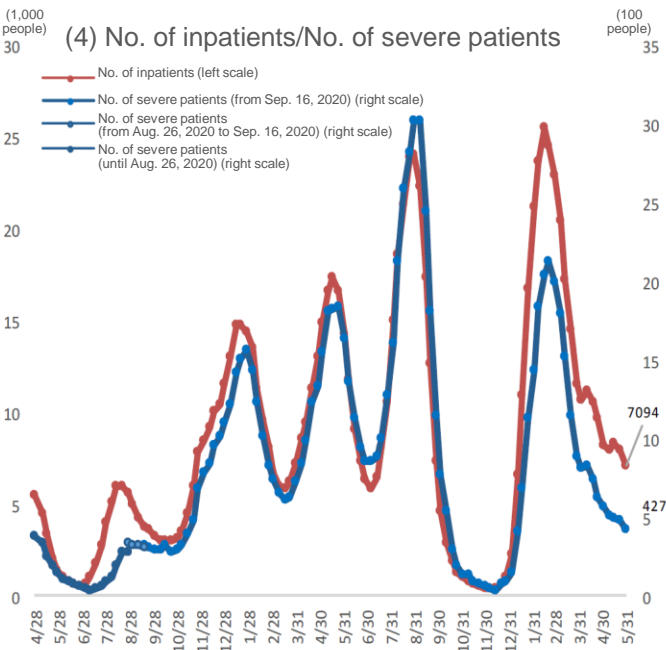
(2) No. of new cases of infection (per 100,000 of the population)/Percentage of unlinked cases



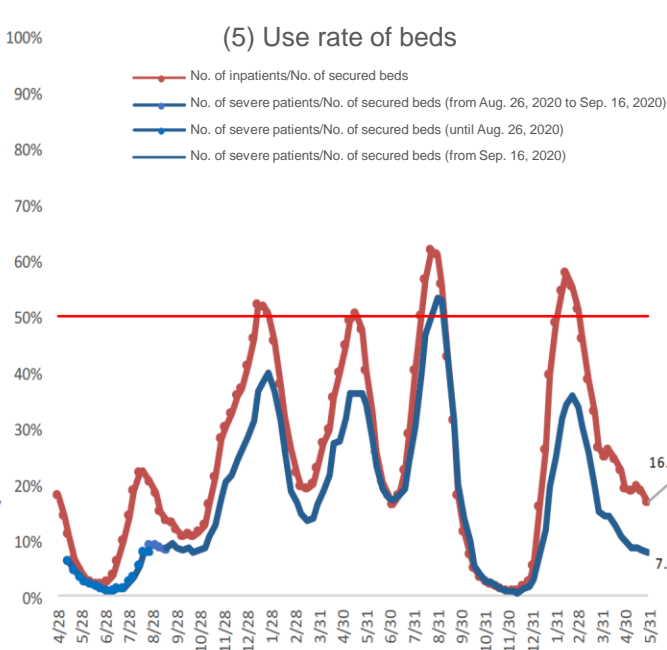
